

## **Gender and Sexual Diversity Survey Invitation Letter**

### **Background**

The 2013-2020 Strategic Plan affirms Sheridan's commitment to providing a learning and working environment that values the inclusiveness of our community.

As part of that commitment a task force was formed to focus on issues related to gender and sexual diversity in the Sheridan community.
